Informed Consent/General Release for all Customers

This is a release of liability. Please read carefully before signing.

Since participation in activities can result in injury, the Ozaukee Sports Center requires that all participants (and their adult parent(s) or guardians) to assume all risks associated with the site's indoor/outdoor activities by signing this general release.

For and in consideration of my child being permitted to participate in **Ozaukee Sports Center** (OSC) activities, I hereby voluntarily release, discharge, waive and relinquish any and all claims or actions for damages for personal injury, permanent disability, death, or property damage which I or my child may have, or which may hereafter accrue to me or my child, as a result of his/her participation in indoor/outdoor activities while at the facility while others play or for any other reason. This release is intended to discharge, in advance, the **Ozaukee Sports Center**, its owners, officers, employees and agents, and the owners from any and all liability arising out of or connected in any way with my child's participation in OSC indoor/outdoor activities, even though that liability may arise out of negligence or carelessness on the part of **Ozaukee Sports Center**, its owners, officers, employees or agents.

I further understand that serious accidents occasionally occur during indoor/outdoor activities at the **Ozaukee Sports Center**, and that participants occasionally sustain serious personal injuries, death or property damage as a consequence thereof. Knowing the risks, I have voluntarily applied for my child to participate in the indoor/outdoor activities and thereby agree to assume those risks and to release and hold harmless the **Ozaukee Sports Center**, its owners, officers, employees and agents, who through negligence or carelessness might otherwise be liable to me or to my child (or my heirs or assigns) for damages.

I further understand and agree that this release, discharge, waiver, and assumption of risk is to be binding on my and my child's heirs, executors, administrators, and assigns.

I further agree to indemnify and to hold harmless **Ozaukee Sports Center**, its owners, officers, employees and agents for any loss, liability damage, cost or expense which may incur as a result of any injury or property damage that I or my child may sustain while participating in the indoor/outdoor activities.

I agree to comply with the **Ozaukee Sports Center's** stated and customary terms and conditions for participation according to the **Ozaukee Sports Center**. If I observe any significant change with regards to my child's readiness for participation in the program, I will remove my child from the program immediately.

I have read this Informed Consent/General Release, fully understanding its terms, that I give up substantial rights by signing it, and sign it voluntarily.
